Library

Susan Rollings, Library Director, approached the Board giving her annual report. Report attached herein. Councilwoman Stanton thanked Susan for all she does for the community and thanked her for always supporting what ever is going on in the Town.

Supervisor Wells also thanked all Departments within the Town stating that the public has been ugly and more demanding this year and wanted to thank everyone for their perseverance.

Ambulance

Joshua Wells, Captain of the Ambulance Corp. approached the Board giving their annual report. Supervisor Wells thanked the Ambulance Corp. for all they do for the community! He stated they were head and shoulders above most other Corps. Councilwoman Stanton commended the Corp. as well, thanking them for all they do.

Councilman Rathbun entered the building at 7:20 p.m.

The Town Board began going through the budget beginning with the Landfill.

Landfill

Discussions were held on running the Landfill as it is being done now. Bill Laprairie, Department Head of Buildings and Grounds stated that having four (4) workers there has worked out nicely to keep the traffic flowing and being able to help the constituents.

Discussion was held on the amount of work that is being laid on the Buildings and Grounds crew.

Having a new building to maintain 2. Working with Cedar River Cemetery (Bill stated that this
would be causing overtime for his men as there would be weekend burials) 3. The crew are now
moving bogs for the Weed District

Discussion held on purchasing a pontoon boat for the removal of bogs. If purchased just for the Weed district, this would come out of the Weed District budget.

Water 1 & 2

Patrick Mahoney, Department Head of Sewer and Water, let the Board know that the backhoe should be here by next week. He also reported to the Board that he would be having some last-minute purchases. Due to a break down he stated he will need to purchase a Vertical Turbine Pump that will be around \$7,000.00 to \$10,000.00. He stated that he will also be purchasing a Vacuum Pump around \$3,000.00 and a finish pump drive and a well pump drive that will be around \$4,000.00. These will be purchased this year out of this budget. Some discussion was held on the Water 1 – Blue Mt. Lake project.

The Board went through Debt Services, Reserves and Planned Fund Balances. Supervisor Wells asked Bill Laprairie, Department Head of Buildings and Grounds to add tree removal to his budget, as the tree next to the welcome center has to come down. Bill stated he had already received quotes and the cost will be around \$12,000.00.

Supervisor Wells closed the meeting at 8:07 p.m. to resume October 14, 2021 at 7:00 p.m.

Dear Indian Lake Town Board Members,

I wish to thank our library trustees, the town board and town hall employees, and our parks and recreation department for your support of your town library. Also, I wish to thank for our retiring trustee president Ernie Pollman, who served as a trustee for 17 years.

We sincerely hope that 2022 will prove a less challenging year, we are starting to see light at the end of this very long pandemic tunnel. Our service to the community thankfully looks very different from 2020, and our approach to the pandemic had 3 core tenets which have served us well: *safety, service, and steadiness*.

- 1. Safety of our co-workers and patrons has been and remains our priority.
- 2. We have adjusted our services to safely accommodate our patrons during this health crisis. Although our doors were closed to public for a time, our digital collection, remote programs, and curbside service allowed patrons access to materials and companionship.
- Steadiness is the reasoned, cautious approach we adopted to serve our public help prevent a backslide on patron access to our building.

My passion in this job has been to provide our community with educational and cultural programs for all ages. Patrons visit to borrow books, audio, and videos but programs do help get people who may not otherwise visit us to borrow materials. Being a fun, welcoming place is a point of pride for my co-workers and myself. My co-workers go above and beyond for our patrons, and our patrons consistently thank us for this.

Program attendance is down from our highs in 2019, but it's been good this year thanks in large part to our school valuing what the library can provide to enrich our children's lives. We've shifted from exclusively remote programming to cautious in person/remote hybrid. Here are some numbers:

Our 2020 circulations were 14,000+ items between our item borrowed locally and through inter-library loans.

WiFi use between January 1, 2021 – September 30, 2021 was accessed 7,635 times and had 3,588 unique users during that period. Already 29% higher than all of 2020.

An NYS construction grant paid for about 75% of our new ADA compliant entrance. Again, many thanks to the Parks and Recreation Department under Bill LaPrairie for making that happen for us. We will apply for another grant through our consortium to help pay for residing our building in 2022.

Part of the library's mission is to promote a love of reading, and a desire for life-long learning and curiosity. We are continuing to uphold that goal and currently updating our plan of service. This summer our planning committee spent numerous hours interviewing fellow citizens to find out what their aspirations are for this community. We're using this information to craft goals for the next 5 years to support our community and its needs. We will publish this plan pending trustee approval by year's end.

Historian Report for 2021

Thank you for allowing me to serve as the Town Historian for the sixth year. Luck allowed me good enough health to accomplish this.

Starting in early May, I rearranged some displays to make room for donations received and a large amount donated by Senator Farley. The boxes of items that the Adirondack Museum Staff didn't want was dropped off at our Town Museum. Meeting me in early April, they left eleven large boxes of plaques, law signing pens, items from organizations thanking for the Senator's support, a broken glass gavel, correspondence, etc. were left here to store. Shelving from the old Stewart's store was placed in the cleaned out down back storage room to hold all of Senator Farley's stuff.

Other donated items include: items from the old Marty's (Chili Nights) such as the largest pike caught in Indian Lake and the trophy for the annual hot chili eating contest.

Another donation were items of Ken Heintz. The large sign from the Adk. Museum when they honored him and boxes of building plans and correspondence when he constructed camp furniture for many famous people such as Sandy Duncan.

Some of the most interesting donated items were old journals and ledgers from local stores. A ledger from the old Sabael Store dates from 1840 to 1844 with entries from residents of the Sabael area. Three other ledgers were given to the Museum that were found years ago in the attic of a home on Starkbuck Rd. in the Big Brook area that was built in the 1850's. This house was next to a dam near to the later Wilderness Lodge. A man named Hoxie had a sawmill there and might have built that house. At another location, he had a store and served meals. This was located across from the Indian River Hotel south of Town. (Across from the current Chain Lakes Road). I feel the ledgers were from there. One is dated 1866, another 1868 and the last one 1870. They list items purchased and meals served. Names of well known locals from the Town proper and adjacent areas are listed. They would have patronized the Indian River Store during that period of time.

It was a busy post-parademic year with visitors from all over NYState, the US and one from Brazil. The visitation was slow in the early season but was real busy in September and Oct. Many people are recent owners of homes and camps in the Town and close by areas.

The season does't stop with the closing of the museum. I constantly do research and reply to Emails and telephone inquires about families and Indian Lake history. I plan on re-opening the museum next year from Memorial Day Weekend to Columbus Day Weekend, the same as this year.

LOCAL OVERRIDE LAW

Local Law No. 1 of the year 2021 Town of Indian Lake, County of Hamilton

A Local Law to override the tax levy limit established in General Municipal Law 3-c

Supervisor Wells offered Local Law # 1 in the year 2021

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Indian Lake, County of Hamilton, pursuant to General Municipal Law 3-c, and to allow the Town of Indian Lake, County of Hamilton to adopt a Town Budget for (a) Town purposes (b) any other special or improvement district governed by the Town Board for the fiscal year 2022 that requires a real property tax levy in excess of the "Tax Limit" as defined by General Municipal Law 3-c.

Section 2. Authority

This Local Law is adopted pursuant to subdivision 5 of General Municipal Law 3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a Local law approved by vote of sixty percent (60%) of the Town Board

Section 3. Tax Levy Limit Override

The Town Board of the Town of Indian Lake, County of Hamilton, is hereby authorized to adopt a Budget for the fiscal year 2022 that requires a real property tax levy in excess of the limit specified in General Municipal Law 3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm, or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective date

This Local Law shall take effect immediately upon filing with the Secretary of the State.
