Testing was completed at all plants daily.

Samples required by DEC and DOH were submitted to the lab.

We got our Annual Quality Water Report. A copy was mailed to each customer in both water districts.

The U.V. units were put in at the sewer plant. We are required by DEC to treat with U.V. from May thru October.

The seasonal water services were turned on in both water districts.

A service line on Cedar River Road had a leak that we dug up and fixed.

There has been a leak on Blue Mt. hill for over a year and a half. We have been having a very difficult time finding it, but we have finally located it and fixed it. We are very relieved to have it fixed as it has been very taxing on the water plant. We could not have found it without the help of NYS Rural Water Association. The leak was out in the lane of the state road and the water was surfacing about 150 feet down the hill on the other side of the road. We had a few of the guys from Rural Water here on several occasions, especially Morris Coolidge, who we want to thank for his persistence in helping us. Through the course of looking for, and fixing, this leak we have received a lot of help and would also like to thank The Parks and Rec Department, The Indian Lake Highway Department, The Town of Long Lake Water Department, The Hamilton County Highway Department, and Tioga Construction. We are a small department with limited resources and could not have completed this task without their assistance.

Building maintenance and operations monthly report May 2022

May started out with us doing BTI in both Blue Mountain and Indian Lake, all the streams we checked and treated were full of larva, low water levels and temperatures fluctuating between freezing and hot weather have helped with the control program this year. It looks like we will be calling the program probably a week or two into June. Graves were dug at three cemeteries, the Benton cemetery the Catholic cemetery and the Cedar River cemetery, after services were over we cleaned up and took care of the gravesites and moved equipment back to shop. We have three more coming up in the month of June all in the Cedar River cemetery. Poured three foundations at the Cedar River cemetery, and need to do two at the Benton.

We cleaned up all town properties from trees and debris, raked all the lawns, trimmed bushes and added topsoil where needed. While we were taking care of the properties we turned on the water at all the towns seasonal buildings.

We finished the install of the border at the playground set at Byron Park, we put up the swings retightened all the hardware and it is now ready for use. The fence between the old volleyball court and the basketball court was taken down and a new split rail fence was installed in its place, we will also be installing one between the horseshoe pits and the new playground so children don't run directly across while people are playing horseshoes.

We have started to make changes at the town beach on Chain Lakes Road, we have taken off 1/2 of the roof and replaced the boards that were rotten and started putting up new steel roofing. We had our electrical inspection and we will be installing lights, power outlets and internet in the future, if all goes well before the beach opens.

We made some repairs to the back stop at the Little League field, we put the bases in to be left there throughout the summer and we stained the dugouts one time, we will give it a second coat in a few weeks.

The flower barrels were brought out of storage and brought to the ski hut to be prepped, after the garden club went through all the barrels we put them out at the locations on the map.

Garbage runs and dam checks are made in Blue Mountain and Indian lake on Tuesdays and Fridays.



Dear Town Board,

The Blue Mountain Lake Association would like to submit the following for 2022 Citizen of the Year:

What makes an outstanding volunteer stand out as Citizen of the Year?

It's hard to capture greatness by writing a list of accomplishments, no matter how long that list is. Sometimes greatness can only be seen when someone enters a room, or more importantly, enters a situation.

It's hard, as an adult, to find someone you will follow without question, one who you look up to, and work hard to *live* up to. Someone you hope to never let down.

It's hard to find a born leader. Because, in fact, they are not born every day. Whether leaders like Greg George are born, or made, they seem to be few and far between. (We are all lucky if there are a few people in our lives who measure up to that, aside from our moms, dads, grandparents and kindergarten teachers).

But maybe, a Citizen of the Year is a born leader, a 24/7 volunteer who leads others, by example.

The Blue Mountain Lake Association proudly nominates Greg George for 2022 Indian Lake Citizen of the Year.

On April 4, 2022, Greg George tried to retire as Chief of the Blue Mountain Lake Volunteer Fire Department, after serving as Chief since 2011. But he couldn't. The BMLVFD could not find one person willing to step up when Greg tried to retire. Not one. In fact, the solution only came when two firefighters, Ken Hinckley and Jim Pine, each took on some of his many responsibilities, with Greg staying in the lead on training for

another full year. If you think about it, what could be more difficult that following in a great person's footsteps? It's not an easy task.

Greg first arrived in Blue Mountain Lake in 1984 as NYS Resident Ranger, previously assigned to the Cooperstown area starting in 1977. During his tenure as Ranger, he rescued hundreds of the lost and injured, extinguished forest fires, surveyed and marked state land boundaries, laid out and blazed trails, became a highly respected incident commander and trainer, and simultaneously volunteered as Blue Mountain Lake's Assistant Fire Chief under a succession of Chiefs, usually doing the bulk of the work but always giving the Chief credit. His outgoing personality and friendly demeanor helped him deliver difficult messages to forest users in violation of regulations, with the miscreants often voluntarily suggesting they'd been at fault. Greg is still a beloved speaker to civilian groups, for example, donning his green Ranger uniform for a weekly nature talk at The Hedges resort.

"Because Greg is Greg."

In 2010 Greg retired from the NYS Rangers, but remained in Blue Mountain Lake, playing an even larger role in the fire company, and becoming Chief in 2011. As Chief, Greg has a remarkable ability to engage ordinary people as volunteers. His monthly training exercises are thoroughly thought out. He has a role for everyone, gradually involving each person more and more.

He has a way of making each person's contribution, no matter how small, seem tremendously important, earning enormous loyalty and team cohesion, as well as eagerness to learn more.

Perhaps the best way to understand his presence, especially in emergencies, is with this example: At a recent rescue on Snowy Mountain, Greg and others were bringing down a dehydrated hiker. When a Ranger arrived at the base to take charge of the scene and learned Greg was already up on the trail, he expressed great relief, saying, "A team of six, led by Greg, that's perfect. Because, you know, Greg is Greg."

Digging deeper into Greg's past

Greg George began his career as a NYS Department of Environmental Conservation Forest Ranger in Cooperstown, NY, in 1977, and requested a transfer to Blue Mountain Lake, NY in 1984. As a Ranger, he was always assisting the community with educational trainings related to his field work including search and rescue, interior trail maintenance, survival skills, rope rescues and carry outs.

A devastating fire in Blue Mountain Lake led Greg to join the Blue Mountain Lake Volunteer Fire Department (BMLVFD) in 1985, where he was immediately inducted as the President. Joining the BMLVFD was just part of his long history as a volunteer in the hamlets of Blue Mountain Lake and Indian Lake. He and his wife, Jean, raised two children which led Greg to become a hockey coach for 12 years. He also helped spearhead the implementation of a NYS grant to build a new ice rink that still is in operation today. With the new rink came the need for a new building to provide access to restrooms, warmth, game tables, storage, and kitchen facilities. The building, known today as The Ski Hut, was built in two weekends by volunteers - an old fashioned "barn raising" Adirondack style. George and his wife helped to organize and gather materials, manpower, and food to feed the masses to complete this huge undertaking.

As the seasons changed, so did Greg's volunteer jobs. Spring and summer brought Little League, and of course, he coached his children's teams, and even continued coaching when his children weren't playing, providing the community with nine years of his time and expertise.

No one. Not one person.

In 2011, after serving since the 1980s, Greg was elected Fire Chef of BMLVFD. Under his leadership over the next 12 years, he would ramp up the training for his fellow volunteer firepersons, which included countless hours of prep.

In addition to organizing, scheduling and prepping training and drills in full PPE, other aspects of the Chief's job include equipment maintenance and readiness, scheduling meetings and reminders there of, keeping department records, and attending other meetings like the County Fire Advisory Board. Because Greg is a powerhouse, and always gets it done, it's easy to see why the department got a bit used to one person handling much of the work.

That brings us full circle to the reason why no one, not one person, would step up when Greg wanted to retire this year! His are big shoes to fill. And it's taking four feet to fill them.

Under the radar

Volunteering to create positive change for a community is in Greg's DNA. These changes are visible to all. But what one doesn't see is that Greg will help any group, or any individual, anywhere, anytime. He's not looking for extra credit. Or any credit at all. Simply put, Greg is not one to sit still. The truth is, there's always someone who needs

help. Whether it's helping others put up a building, fixing someone's burst water pipes, rescuing a trapped cat, or stopping by to scrap an unwatched exploded pot of boiled eggs off the ceiling for an elderly person (but that's a story for another time).

The problem with Greg is ...

The problem is, one hates to ask Greg for help, because if he doesn't have the time, he will make the time. He will not pass it off, he will get it done. No matter what.

He never gives up.

There is no one kinder, more capable, or more willing than Greg George to give someone, anyone, his best help, which is always excellent. If Greg can't quickly assess and solve a problem, bets are that problem can't be solved. Except, Greg George would never give up. He would find a way to conquer it. There is no one who does more, offers more, volunteers more. And always shows up. Teacher, mentor, guide, friend, neighbor, volunteer.

In our humble opinion, Greg George is an outstanding choice for 2022 Citizen of the Year. Thank you.

SURPLUS PROPERTY REMOVAL AGREEMENT Between TOWN OF INDIAN LAKE And ERIC SMITH d/b/a REN-WASH SALVAGE

This agreement, made this day of 2022 by and between the Town of Indian Lake, a Municipal Corporation of the State of New York, having its offices at 117 Pelon Rd, P O Box 730, Indian Lake, NY 12842 (Town) and Eric Smith, d/b/a Ren-Wash Salvage "Sole Proprietor" of Schaghticoke, NY (Contractor)

WHEREAS, The "Town" is the owner of scrape metal received by Hamilton County residents at the town recycling area located on Chain Lakes Road in the Town of Indian Lake: and

WHEREAS, Town Law specifically grants the power, with the approval of the majority of the Town Board, to dispose of surplus property owned by the "Town", and

WHEREAS, "Contractor" has expressed a desire in obtaining the scrape metal owned by the "Town" and removing same from town property; and

WHEREAS, the "Town" is willing to grant the "Contractor" and agreement to permit access to said land and remove surplus property (scrap metal) in a manner that is beneficial to "Contractor" and the residents of the Town of Indian Lake, in general; now therefore, be it,

RESOLVED, that in consideration of the mutual promises contained herein, the "Town" hereby grants "Contractor" a revocable contract for the purpose of removing surplus property (scrap metal) on the above referenced lands for the term of one (1) year beginning on the day of day of 20 22 in accordance with the terms and conditions contained herein;

- 1) The material is offered on an "as is" and "where is" basis, and the "Town" makes no guarantee as to its condition;
- "Contractor" shall be responsible for removing the material from the town property, including all related costs including, but not limited to, transportation, handling, and equipment maintenance;
- 3) "Contractor" assumes complete ownership and responsibility of the scrap metal upon initial handling;
- 4) "Contractor" shall pay the town one hundred (100) dollars per ton less, than the gross revenues received from the sale of scrap metal and a load slip indicating gross weight will be provided with payment;
- 5) "Contractor" shall distribute funds from the sale of scrap to the "Town" within 15 business days from the day of removal:

- 6) All removal operations will be done in a proper, good and workmanlike manner, so that the same shall in no way endanger the public and be subject to the approval of the "Town"
- 7) Removal operations shall occur during normal working hours and the equipment and removal of surplus property shall not interfere with the operations of the recycling facility or any other town entity;
- 8) "Contractor" shall provide the service in full compliance with all applicable federal, state, and local laws, rules, regulations and orders of all governmental agencies and entities, including but not limited to federal, state and local environmental, transportation, labor and industries, health and fire regulations, as applicable;
- 9) "Contractor" shall not be considered in any way to be the employee, agent, or representative of the "Town" and shall at all times indemnify and hold harmless the "Town" and its employees, representatives, elected officials and officers from and against any and all actions, suits, damages, costs, charges and expenses due to injury or property damage caused by or arising from such removal or work undertaken by "Contractor";
- 10) "Contractor" shall have at least (1) year experience in the business of recycling scrap metal;
- 11) All scrap metal accepted under this contract shall be recycled in some manner and shall not be landfilled:
- 12) "Contractor" shall immediately advise the "Town" of any change in the contractors regulatory or compliance status, and of any notice of violation, citation, administrative order, court order, judgement or other regulatory or enforcement action initiated against the contractor by any governmental agency or entity. The "Contractor" shall fully cooperate with the "Town" in its investigation of any permitting, approval or compliance matters;
- 13) All notices required or permitted to be given under this Agreement shall be in writing and shall be sent by either mail, return receipt requested, overnight courier service, or by facsimile transmission if applicable;



- 14) "Contactor" agrees to remove all the scrap metal produced and accumulated by the "Town", and will pick same up at reasonable intervals or within 10 business days of written request from the "Town";
- 15) "Contractor" shall assume full responsibility for damage to town property during the removal of the material. Repairs of any damage shall be completed to the "Towns" satisfaction. If repairs are not done to the "Towns" satisfaction, the "Town" reserves the right to procure the services of a qualified contractor and the "Contractor" shall reimburse the town for the cost of the repairs;
- 16) "Contractor" agrees to pay all collection fees incurred by the "Town" or for any fees incurred for the enforcement of this agreement, including reasonable attorney's fees;
- 17) Eric Smith represents that he is the sole employee of Ren-Wash Salvage and agrees that during the term of this agreement he shall employ no other person or firm to remove and take ownership of the "Towns" scrap, without giving the "Town" at least 10 days prior written notice;
- 18) "Contractor" may NOT re-assign this agreement without "Towns" prior written consent;
- 19) This agreement shall terminate it "Town" determines that "Contractors" equipment objectionably interferes with the operation of the recycling facility, and that this interference cannot or will not be corrected by "Contractor";
- 20) "Town" or "Contractor" may terminate this agreement after ninety (90) days written notice to the other party.
