INTRODUCTION

To comply with State and Federal regulations, the Town of Indian Lake annually issues a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other standards. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and in some cases radioactive material and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

The sources of water for Indian Lake Water District #2 are four drilled wells. The water from the wells is pumped into the new water plant where it is pre-treated with sodium hydroxide and chlorine before it is pumped through iron and manganese removal filters. The water is disinfected with chlorine before it flows into the 42,000-gallon storage tank below the treatment building. The water is pumped into the distribution system with 2 - 250 gpm pumps. There is an emergency generator to run the water plant n the event of power failure. The distribution system consists of mostly 6" and 8" cast iron piping and some AC piping. There are two storage tanks; a 100,000-gallon glass lined tank and a 150,000-gallon steel tank located on Tower Road. We serve 900 people through 450 service connections.

The NYS Dept. of Health has completed a source water assessment for this system based on available information. The issessment includes an assigned susceptibility rating based on the risk posed by each possible source of contamination and how asily contaminants can move through the ground to the wells. The susceptibility rating is only a rough estimate of the potential or contamination of the source water and it does not mean that the water delivered to consumers is or will become contaminated. It is mentioned earlier in this report, our water is derived from drilled wells. The source water assessment has rated these wells as aving an elevated susceptibility. No significant sources of contamination were identified. The health department will use this information to direct future source water protection activities.

RE THERE CONTAMINANTS IN OUR DRINKING WATER?

s the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include stal coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes, aloacetic acids, radiological and synthetic organic compounds. The table presented below depicts which compounds were etected in your drinking water. The State allows us to test for some contaminants less than once per year because the oncentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year d.

uring 2021, we started to sample our drinking water for the per- and polyfluorinated compounds PFOA and PFOS and 1,4-oxane on a quarterly basis. We collected samples from our four wells on a rotating basis during the 4 quarters of 2021 for PFOS d PFOA and the results indicated that there were low levels PFAS chemicals present in our water. Results for 1,4-dioxane mples were below the detection limit. PFAS and 1,4-dioxane was not detected in our water in 2022. We will sample again in 23 for these parameters.

should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small nounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. - The level presented represents the 90th percentile of the 20 sites tested. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the lead or copper values detected at your water system. In this case, 20 samples were collected at your water system and the 90th percentile value was the second highest value.
- The levels presented represent the range of the lead and copper samples collected. The action level for lead and copper was not exceeded at any location.
- The levels represent the range of disinfection byproducts collected in our system at two locations.
- Water containing more than 20 mg/l of sodium should not be used for drinking by people on severely restricted sodium diets. Water containing more than 270 mg/l of sodium should not be used for drinking by people on moderately restricted sodium diets.

efinitions

<u>faximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as ose to the MCLGs as feasible.

<u>faximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or spected risk to health. MCLGs allow for a margin of safety.

<u>faximum Residual Disinfectant Level (MRDL)</u>: The highest level of a disinfectant allowed in drinking water. There is invincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

<u>aximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant below which there is no lown or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial ntamination.

etion Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a ster system must follow.

eatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

on-Detects (ND): Laboratory analysis indicates that the constituent is not present.

rephelometric Turbidity Unit (NTU): A measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the erage person.

<u>illigrams per liter (mg/l)</u>: Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).

crograms per liter (ug/l): Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).

<u>cocuries per liter (pCi/L)</u> – picocuries per liter is a measure of the radioactivity in water.

nograms per liter (ng/l) corresponds to one part of liquid to one trillion parts of liquid (parts per trillion - ppt).

WHAT DOES THIS INFORMATION MEAN?

As you can see by the table, we had no violations in 2022. In 2021, we had an Action Level exceedance for copper. As a result of this Action Level Exceedance, we began adding a zinc orthophosphate corrosion control inhibitor to our water. Additionally, we sampled 20 sampling locations (as opposed to the standard 10 sampling locations) two separate times during 2022. 2022 sampling results indicate that the corrosion control inhibitor is doing its job and both lead and copper levels were below Action Levels.

We have learned through our testing that other contaminants have been detected, however, these contaminants were below the level allowed by the state. Even though the action level for lead was not exceeded at any of our sampling locations, we are required to present the following information on lead in drinking water:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. The Indian Lake Water District #2 is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

Last year, our system was in compliance with all applicable New York State drinking water operating, monitoring, and reporting requirements.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other mmune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. EPA/CDC guidelines on appropriate means to lessen the risk of nfection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-126-4791).

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is nportant to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life;
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential firefighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a
 run for your money and load it to capacity.
- Turn off the tap when brushing your teeth.
- Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it and you can save almost 6,000 gallons per year.
- Check your toilets for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

CLOSING
