Building maintenance operation report November 2024

Trail work continued throughout the month of November, we installed culverts, worked on drainage ditches, hauled material, and cleared trails from fallen trees and blowdown. We did as much as we could before the snow came and we have pulled our equipment and are prepping for grooming which starts after the first full weekend in December.

At the welcome center we installed 4 inch conduit and backfilled prepping for DANC to come and install the fiber lines and making sure everything was cleaned up before winter plowing. We hauled away the old freezer panels that were no good, and we are waiting on a signed contract to continue work on the building.

Tim and Davanna Marks donated this year's Town Christmas tree, we went over to their property and they showed us a tree and we returned a week later cut the tree and installed in the little park. We put up banners for the country Christmas tour and three large signs at our town signs to promote the event.

The town had grant money to use so Kim and I purchased a bunch of gaming tables and board games for up at the rec center, there is now a brand new pool table, basketball game, foosball table, air hockey table, ping-pong table, ski ball table, and two chess boards, all these are new and so far a big success with people who have used the building.

At the Library we framed up and poured a generator pad, and will be doing a below ground propane tank.

We cleaned up our yard just in time for the first snow, we plowed and shoveled all of our Town buildings, salted walks as needed, and plowed the transfer station, welcome center and parking lots.

Made major repairs to the side-by-side, axles, bearings and new drive shaft.

Community/Economic Development

ILCDC's SIB (Sabael, Indian Lake, Blue Mountain Lake Re-Vibe) Committee — ILCDC is currently considering dissolving.

In person networking events/seminars attended in November included (1) Climate Change with A.C.O.R.N. discussing how the changes in climate have impacted on our communities; (2) DEI (Diversity, Equality & Inclusion) Symposium with ANCA; (3) Common Ground Alliance where I served as a group facilitator; and (4) Hamilton Helps with Blue Mountain Center, Adirondack Foundation and ADKAction. These networking events help the Town expand its reach in other Adirondack communities and for Kyli and me to make connections with leaders in other organizations. These types of connections often develop leads for grants, such as being asked by Cali Brooks, CEO of the Adirondack Foundation, to apply for a new opportunity called the Kindling Awards. This is the description of their new program: In the Adirondacks, we lean on one another to hold our communities together, to meet needs and build a more positive future, to serve those who are isolated and create space to be together. After a difficult and divided election, Adirondack Foundation wants to surface a sense of optimism and social connection through our new Kindling Awards, named after the key ingredient, that starts a warm fire we gather around.

We are looking for nominations from anyone and everyone for the best winter community events in towns throughout the Adirondack region that bring a wide variety of people together to connect and build relationships. No agendas necessary beyond fighting isolation and building community. Thirty of the best nominations will receive a \$1,000 Kindling Award and promotion on social media. We are especially looking for events hosted by non-traditional groups that are community-driven and authentic, as well as successful at bringing isolated people together. The events can be something already planned or something new but must take place before May 2025.

Events

Black Fly Challenge (BFC) will start in Indian lake next year and will be held on 6/14/25. Due to dam construction on lake Adirondack an alternative location must be selected. The BFC steering committee met with me on 12/2/24 to tour alternate locations. The top two picks were to start at Town Hall or the ball field. I'd like to have a brief discussion and get board approval at this month's meeting.

Marketing

All calendars of events continue to be updated on a regular basis as needed. We are a member of the IABA in Inlet so they also post and share our events.

Flyers, maps, and town event rack cards are refilled throughout the community on a weekly basis and as needed. We will now be providing locations with snowmobile maps and will have the SNOCADE placemats in locations by Martin Luther King weekend (Jan. 17-22, 2025).

Grants

NYS SWIMS application was submitted on 11/8/2024 with an request for \$9,950. Award announcements are expected before April 2025.

Northern Forest Adirondack Housing Pre-Development Assistance Program RFP was submitted on 11/8/2024. This RFP was seeking proposals from ADK municipalities wishing to receive predevelopment technical support for potential housing projects. Support would include pre-development activities and preparing potential information packets for potential developers. They will choose 10 projects to receive desktop due diligence and feasibility assessments such as zoning review, review of easements, potential grant and tax credit funding, etc. Of the ten, five will be selected as the most suitable for development and will advance to a deeper pre-development phase. Project awards will be announced on 12/6/24. I submitted the Commons Project for consideration. This opportunity also arose from a networking event I attended as well as participation in many Zoom housing series.

<u>DASNY/SAM Grants</u> – We received a call from Senator Walczyk on 11/1/24 saying they are working on getting \$50,000 of the \$300,000 released early in 2025. We should be receiving paperwork to process after the new year.

<u>DEC EV Charging Stations</u> – Still waiting for the agencies to sign and deliver a fully executed contract.

<u>Adirondack Park Upper Hudson Rec Grant – We submitted and received the last installment for this grant.</u> I am awaiting proofs for trail markers and rules and regulation signage.

<u>DEC ZEV Rebate</u> - We are still waiting for the rebate to arrive.

ADKAction Partnership with Town Landfill Project. We continue to have quarterly meetings with NYSDEC as they want to keep a close eye on this project as it will be the first of its type in Adirondack Park. I participate in these meetings. On 11/8/24, we had a meeting at the landfill with 2 members of the ADKAction team, Cornell Cooperative Extension and Hamilton County Soil and

water. Soil samples were taken and sent in for testing. The samples will help guide the team to determine if additional nutrients need to be added to the soil. An RFP for environmental scientists/advisors has been sent out as well.

- # 195 Sander Rebuilt sander tail shaft including spinner shaft and spinner shaft bearings. New couplers and keyways.
- # 182 Freightliner Replaced two drive axle tires on driver side of truck
- # 3320 John deere tractor (Sidewalk Snowblower) Installed new 60 inch heavy duty front mount snowblower purchased from Falls Farm and Garden. Installed new frame mounts and lift cylinder that were included with the blower.
- Kubota Mini 121 Road call to Abanake Lake road to retrieve excavator with dismounted track. Brought back to shop Removed left hand side track the rest of the way and removed front idler and track tensioner assembly. Cleaned and inspected undercarriage and found no issues. Reinstalled track and set proper track tension.
- #188 2019 F 350 Received the rest of the parts order to complete the rear brakes. Installed new rear brake rotors, pads and axle seals.
- # 192 John Deere 544 G Removed front remote hydraulic lines for new snowplow and move hydraulic couplers to a more suitable location and installed new lines.
- # 181 Sander Brought into shop and began pre season service before installing into truck. Found spinner shaft chain and Auger drag chain both needing replacement.
 We had spinner shaft chain in stock but had to order Auger drag chain from Trius industries in Fort Edward New York. I ordered two chains. One chain for stock. This chain fits 3 of our sanders.
- # 186 2009 Western Star Brought back into the shop to fix leaking oil pan found when we did pre plow season service. Drained engine oil and removed any hydraulic lines and wiring necessary to remove oil pan. Removed all bolts and dropped engine oil pan out of the frame. Cleaned engine block and degreased oil pan and inspected for cracks. None found installed new oil pan gasket and installed oil pan back onto truck. Performed service with new filters and oil. Test drove truck and got to operating temperature and checked for leaks. Truck no longer leaks.

- #193 John deere 544k Installed two new batteries
- # Bobcat Toolcat Brought machine in due to auger not functioning properly. Found metal jammed in auger shoot removed metal and snowblower functions as it should now.
- Cleared shop and swept floors for firetruck overnight storage.
- #181 2017 Dodge ram 3500 Brought into shop due to brake fluid leak from rear axle. Removed tires and found brake pads worn through to the point of caliper pistons pushing out and cracking. Installed new rotors, pads, calipers, brake lines. Due to the design, you must remove axles to replace brake rotors. Replaced inside hub seals and axle seals upon installation. Bleed new calipers and topped off rear axle differential oil. Test drove and checked for leaks.
- #188 Installed front plow onto truck. Truck suffers from a severe short in wiring harness. Traced wires and tested separate components. Haven't found issue yet.
