Supervisor Wells stated that in the minutes we found out that it was a forever permit, the APA has very little information that they have found regarding it. Supervisor Wells said that the Town board will get together with the advisory board once we have gathered more information.

Resolution No. 6 Local Law No. 1 was introduced by Councilperson Rathbun seconded by Councilperson Mahoney. All were in favor.

C & D Rates:

Supervisor Wells stated we have a recommendation from our account clerk to increase the C&D rates. Councilperson Howard stated the would like to increase it to \$80.00 for the remainder of the year. Seconded by Councilperson Mahoney. All were in favor.

Supervisor Comments:

Supervisor Wells stated that Hamilton County would like to change the speed limits for Lake Durant Road and Lake Shore Drive from 30 to 25 mph.

Supervisor Wells said that he will be sending information regarding Local Law to the attorney regarding batteries, once we receive it back from the attorney he would like to file it. Councilperson Howard motioned. Seconded by Supervisor Wells. All were in favor.
